INFORMATION ON THE PROCESSING OF PERSONAL DATA (PRIVACY POLICY)

FOREL SPA, a sole proprietorship with registered office in Via per Monastier, n. 4 - 31056 - Vallio di Roncade (TV), as the controller of the processing of your personal data (hereinafter "Data Controller"), provides this information to the Data Subject pursuant to the European and Italian laws on the protection of personal data. If the data subject has navigated our website, this information integrates the navigation policy in order to illustrate to the User how the Data Controller will specifically process the data entered in the registration. Please read our <u>privacy policy</u>.

Legal basis and purpose of the processing

The Data Controller processes the personal data for the following purposes:

- 1) to allow the user to view the video containing information on how to operate FOREL-branded machines. The legal basis is the need to satisfy the Data Subject's request;
- 2) to use the Data Subject's contact details for sending commercial communications containing information on its products or services: specific consent is required for this purpose.

Data retention period

The Data Controller intends to process data according to the following time criteria:

- ✓ for the purpose referred to in point 1), the data will be processed for the time needed to review and fulfil your request;
- ✓ for the purpose referred to in point 2), the data will be processed for 24 months from the date of consent or until a request to unsubscribe is received, whichever comes first.

Nature of data provision and consequences of refusal to provide data

The provision of data for the purposes referred to in point 1) is necessary, and therefore, any refusal to provide such data in whole or in part may make it impossible for the Data Controller to pursue the purposes above. The provision of data for further purposes is optional: failing this, the Data Controller will not be able to carry out the corresponding activities but will still be entitled to pursue the purposes referred to in point 1).

Categories of Recipients

The Data Controller will not disseminate the data but may communicate them to people within the Company who have been authorised to process them on account of their duties, as well as to professionals or service companies and Public and Private Bodies, also following inspections and audits.

Should these recipients process data on behalf of the Data Controller, they will be appointed as data processors with a specific contract or other legal document.

Transfer of data to a third country and/or international organisation

The Data Controller may need to transfer data within the scope of relations with business partners established outside the European Economic Area, as well as due to the use of IT services (cloud, backup, etc.). In all these cases, data transfers shall be made in accordance with the specific requirements set out in the data protection regulations, and based on the adoption of Standard Contractual Clauses with suppliers.

Rights of Data Subjects

Data subjects have the right to ask the Data Controller to access their personal data and to rectify any inaccuracies, to erase them or limit the processing if conditions are applicable, and to obtain the portability of data provided personally, only if processed automatically based on consent or on a contract. Data subjects also have the right to withdraw the consent given for the processing purposes that require it, without this affecting the lawfulness of the processing carried out until the moment of withdrawal.
